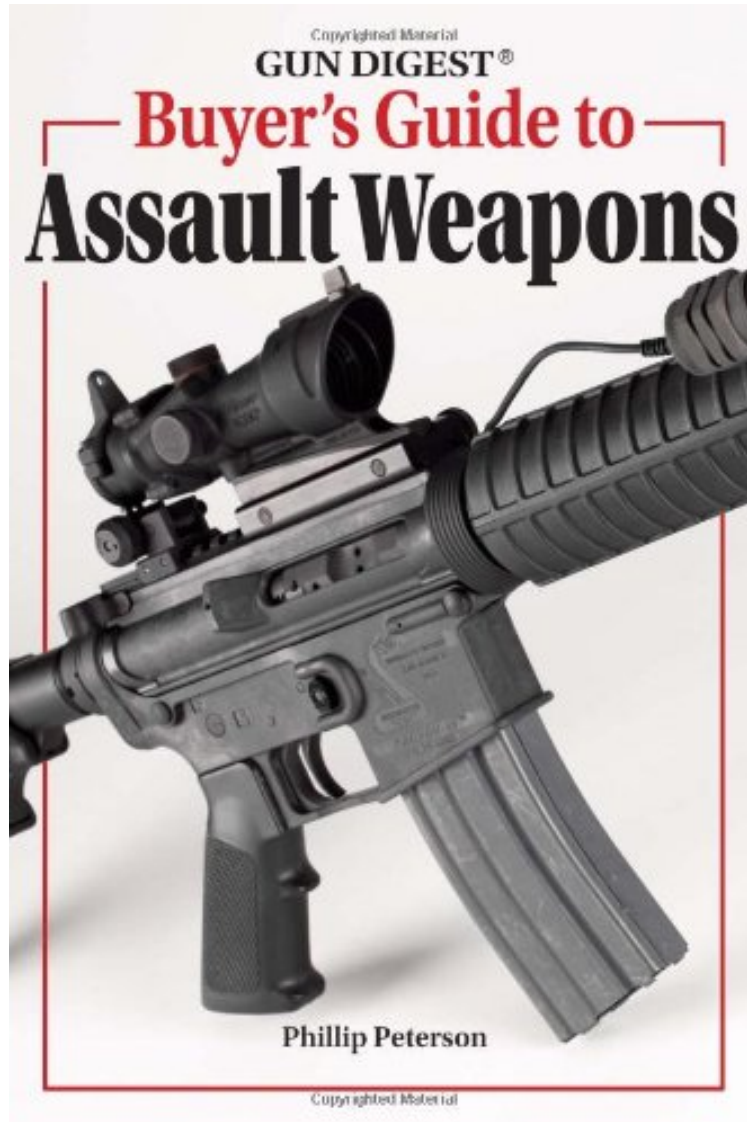

I bought this book as a reference guide to assault weapons as I have found that those who are most in favor of 2nd Amendment rights and lax gun laws (absent the meaning of "well regulated militia"), often use their detailed knowledge of guns to belittle those who wish tighter gun controls and who have little or no knowledge of

guns. While this book appears to contain a lot of content and photos it was obviously not professionally designed and laid out to be a useful guide. There's even an embarrassing error regarding chapter order. On the other hand, I felt the introduction was well written and reasoned but it was all down hill from there especially in terms of layout and presentation. For these reasons, I would not recommend this book. If anyone knows of a better reference, please let me know. p.s. I am not interested in debating gun rights and the 2nd Amendment in this forum.
